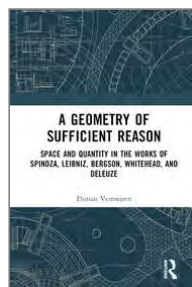

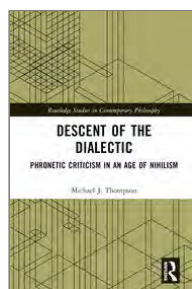
This book compares the reflections on space and quantity found in the works of Spinoza, Leibniz, Bergson, Whitehead, and Deleuze. What unites these philosophers is a series of metaphysical concerns rooted in 17th-century rationalism and embraced in 20th-century philosophies of process and difference. At the heart of these concerns is the need for a comprehensive metaphysical account of the diversity and individuality of things. This demand leads to a shared critique of Cartesian and Newtonian conceptions of space and their notions of homogeneity. In essence, uniform space fails to explain the differences between locations, thus violating the principle of sufficient reason.

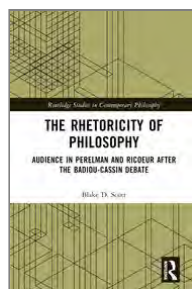

The second part constructs an alternative basis for critical reason by showing how it requires seeing human value as constituted by objective forms of sociality that either promote human freedom or pervert our capacities and drives toward pathological forms of life. A critical theory of ethics must be rooted in these concrete forms of life and serve as a critical vantage point for political judgment and praxis.
